7:15 pm Meeting called to order by Chairman Stevens. Stevens states that we will start on line 110 due to the fact that the revenues are pre set and cannot be voted on. Chief Carrier interjected the fact that the shared revenue block grants are not in place for this year.

Category 110- Auger motions to accept the commissioner's proposal of \$611,782. Second by Virgin. Chief Carrier states that the raise he proposed was for an average increase of 0.577%. Discussion by LaChapelle for the concern of 0% increase if the employees are feeling an increase in healthcare cost that they pay out of pocket. Group discussion on dissemination of benefit plans/co-pays.

Motion by Virgin to accept Chiefs proposal of \$625,501, second by Fogg. **Passed 4 to 1**

Category 110.05- Fogg motioned to accept Chiefs proposal of \$25,410, Virgin second. Passed 4 to 1

Category 110.06- Fogg motions to accept Chiefs proposal of \$130,000, Virgin seconds. Discussion of ways to cut over-time cost. Stevens states where there is a will there is a way. Levels of service discussed by using per diem staff. LaChapelle states possible cost savings in vacation buyout? Chief stated that his original figure of \$142,000 was trimmed to \$130,000. Virgin request 2009 actual OT to date. With lack of all info needed Fogg and Virgin withdraw motion and second.

No vote. Chairman Stevens states we will discuss this line at the next meeting.

Category 320- Virgin motioned to accept Chiefs proposal, second by Fogg. Discussion of why Commissioners see the need for increase legal cost. Auger states that the commission foresees increased need for legal advice. **Failed**

Category 411 Virgin motioned to pass as written, second by LaChapelle. Discussion about the pre buy price and the predicted drop in oil prices. Chief Carrier reported that he believes that the total cost for oil last year was under \$10k. LaChapelle motioned to amend to \$10k to split the difference of what the Chief and Commission proposed.

Category 412 LaChapelle motioned to accept Commissioners proposal of \$1200, second by Flanders. Lengthy discussion of why the district pays a domestic water bill if we pay a substantial bill for the hydrant system. It was agreed that this is a separate utility that should be paid.

Category 413 Motion by Fogg to accept the Chiefs proposal of \$700. LaChapelle second.

Passed Unanimously

Category 430 Virgin motioned to accept as written, second by Fogg. Flanders asked where we the FD has oil changes done. Chief Carrier stated Harbours'. Chief also stated that parts are ordered by Harbour and billed to the FD.

Passed 4 to 1

Category 480 Motion by Fogg and second by Virgin to accept as written. **Passed Unanimously**

Category 550 Motion by Auger and second by Flanders to accept Commissioners proposal of \$1200. No discussion.

Passed Unanimously

Category 560 Motion by Fogg and second by Virgin to accept Chiefs proposal of \$2000. Discussion on what this line covers. Chief Carrier stated that this is for meetings and memberships.

Passed 4 to 1

Category 590.2 Auger motioned and LaChapelle second to accept the Commissioners proposal of \$115k. Discussion about the substantial cost for hydrants. Chairman Stevens thought we should discuss this more at the next meeting.

Failed 1 to 4

Chairman Stevens advised that we had struck the two hour mark and that the meeting is adjourned. Next Meeting on December 7th at the Church on Center Street.
