Reports of Committees

Building Committee

Tim Sattler gave report. Extensive discussion ensued regarding a written charge.

Commissioner Sattler made a motion to acknowledge receipt of the Program Evaluation and are in favor of it. Commissioner Auger seconded the motion. There being no discussion, vote was taken. Motion passed.

Commissioner Sattler made a motion that the Commissioners approve the following as a charge for the Committee.

TNFD Fire Commissioner Charge to the 2021 Building Committee

Recommend to the Commissioners a shovel-ready plan that can be voted on at the 2024 District Meeting for a fire station that meets the District's current needs.

Commissioner Pyra seconded the motion. There being no discussion, vote was taken. Motion passed.

Chief's Report

Budaet:

- The 2022 audit has occurred. We are waiting for the final documentation.
- The 2023 Budget has been expended 47.6%. We are 50% through the fiscal year.
- Total Apparatus and Equipment Fund Balance through June: \$740,593.44.
- 2023 Ambulance Revenue through June: \$255,787.99.

Pressurized Hydrant Use

No use in June 2023.

Fire Prevention Report for June 2023

- Report included in handout.
- For the Month of June, there were 58 Fire Prevention inspections.

Run Report for June 2023

- Run report included in handout.
- For the Month of June, we had 177 incidents.
- 127 of the incidents were EMS in nature and that equates to 72% of our total incident volume for the month.
- The engine responded with the ambulance to 55 EMS & MVA incidents last month.

Overlapping/Simultaneous Incidents for June 2023

- Report included in handout.
- We had 96 overlapping/simultaneous incidents for the month.
- Overlapping/simultaneous incidents accounted for 54% of all incidents for the Month of June.
- We received 16 mutual aid Ambulance responses, eight transported.
- We responded to nine mutual aid Ambulance requests, five transported.
- We received two mutual aid Engine responses.
- We responded to three mutual aid Engine requests.

Apparatus

- 21A1: AC has been repaired and the rear doors have been rebuilt.
- 21A1: Opticom has been replaced.
- All pumps passed the pump certification test.

Grants

- SAFER Grant is up-to-date on reimbursements.
- Homeland Security Grant has been awarded in the amount of \$53,853.00 for radio infrastructure upgrades. Equipment has been ordered.
- Applied for a FY 2022 SAFER Grant to extend current SAFER Employees another three years.

Center Street

Waiting for installation of the camera system.

Park Street

- Cell tower is operational.
- Receiving monthly checks of \$1,537.50 for rent on the tower lease. The rent will be adjusted upward as tenants come online.

SAFER Effect

- Average response time to second or greater calls: 07:18 from 22:30.
- The cost of a SAFER Firefighter in 2022 would have been \$0.04/\$1,000 on the tax rate in Northfield and \$0.07/\$1,000 in Tilton.

- New employees starting July 10th.

Currently Working On

- New Dry Hydrant & Water Cistern Locations
- Drv Hvdrants:
 - o 299 Sanborn Road, Tilton is to be installed in the Spring.
 - DES permits in hand.
 - Jay's Marina application was approved. Installation is scheduled to take place sometime in July.
- Cisterns
 - Another location on Vista Heights in Tilton is being considered at this time.
 - o The Preserve was installed but is not operational as yet.
 - o No DES permit needed.

- SAFER Grant implementation.
 - o 2023 Second Quarter reimbursement has been requested.
